Request to approve Martin's Sugarbush Farm in Caledonia as a seasonal vendor. Martin's started at the market in 2024 and met all of the requirements of becoming a seasonal vendor.

3. Crafters:

Request to change the number of crafters allowed as a seasonal vendor from 10 to 8.

Request the following changes to rules of operations under Concession Vendors: Placement is at the discretion of Market Management. Vendors with food trucks or trailers are given preference for placement in front of the Barn. Vendors with tents will be placed in an appropriate area elsewhere in the Market. One 10 x 10 tent and tables are allowed. Vendors may not park vehicles or trailers next to their tents. Saturday tent vendor participation priority goes to those who also participate during the weekday Market.
